**4. Completed Dental Screening (Part 2 of 1300/1)**

- a) Obtain **LABELED and LEGIBLE** dental images (within 2 years). Exam notes and current plan of treatment (within 12 months)  
Must have **PATIENT NAME, DATE images were taken, and TITLE on the image.** (i.e. Bitewing, Panoramic, etc.)
- b) Take all civilian dental records to NHP Dental on 2nd deck and have them sign 1300/1 Part 2.
- c) Please call ahead for availability (**Monday-Friday; 0800-1200**): Dental Clinic: **(850)-505-6454**

**5. Completed Medical Packet**

- a) If seeing any civilian medical facilities please retrieve all medical records that include physicals, any documentation on any chronic illness you have, and any other records from the past 5 years.
- b) Female's 21-29 need records of an up to date Pap smear within 3 years, 30 + pap records within 5 years, and 40+ need a current mammogram within the last 5 years.
- c) No outstanding medical issues (surgical procedures, mental health treatment, physical therapy, etc.)

**Once you have completed all 5 steps above please bring your Suitability Screening Packet to Patient Administration to schedule your appointment.**
